Abstract:

In a horrific crime, the Saudi Arabian warplanes targeted a crowded civilian market in Na'aidt Area - Sanhan and Belad Al-Roos District - Sana'a Governorate resulted in the killing of 24 civilians who were selling and shopping and the injuring of about other 7.Civilian properties in the area have also been destroyed including shops and cars. Panic and fear spread among civilians.

Incident Details

On Monday, December 4, 2017 and specifically at about 3.30 pm, the warplanes of the Saudi alliance launched an air raid on Na'aidt. The rocket fired by the Saudi Arabian warplanes targeted a group of civilians who were selling and buying Qat, killing about 24 civilians whose bodies were torn and wounding seven others who were in the market. They were then taken to



hospital. The attack also destroyed some shops and a car (Accent model) completely

victims and witnesses' Testimonies:

Witness / Muhammad Abdullah Saleh Al-Shami, 43 years old and the father of the two children who were wounded. whose car was destroyed by the raid, told us saying:

[&]quot;I was in my house near Na'aidt market during the raid at about 3.30 pm"

My children had driven to the market to buy some needs and when I heard the launching of the warplanes I went out of my house and saw smoke rising from the market side. I tried to call my eldest son Hmaid but his phone was closed. I ran quickly to the market. I saw the my car was burning and people gathering the bodies of the victims whose bodies scattered throughout the area. I was terrified and thought I had lost my children. Then I heard one of the sons of our neighbor calling me that my children are fine, I did not believe his words until I saw them my eyes.,

Four of my children were on the car and miraculously survived only three of them were injured and were taken to the hospital. The attack resulted in the killing of approximately 24 people from the region and wounding of 6, three of whom were my children.

Muhammad added

"Why did the military warplanes of the Saudi alliance target this popular market and kill



Witness /Abdulqader Ali Ali al-Nashba, 23 years old, and one of the of the region residents told us:

ordinary civilians!!, most of whom are selling Qat to get livelihood".

"At approximately 3.30 pm, the warplanes of the Saudi alliance launched an air raid on a market in the region of Na'aidt, targeting a gathering of citizens working in Al-Qat selling. I went after the explosion directly to the place of the incident, It was a tragic sight, the remains of the citizens and their bodies scattered in the place.

The attack resulted in the killing of about 24 civilians and the wounding of six. We took the wounded directly to the hospital to receive treatment.

Witness / Saeed Ali Ali Al-Nashba, aged 27 and a paramedic, told us the details of the incident, saying:


While I was at my farm near Na'aidt market, the military warplanes of the Saudi alliance surprised us by an air raid targeting the market. Then I rushed to

the market and was surprised to see the bodies of the citizens scattered on the ground.

We took those who were still alive to hospital. The air strike resulted in the killing of about 24 people (sellers and shoppers) including my relative / Abdul Salam al-Shami, and my cousin / Ali Abdullah Nashba, who were working on selling gat.

Description of the violation according to the international humanitarian law:

legal center has revised the incident and made a full field scan on the targeted area especially the market that was bombed and found that the area and the market are residential objects. It is known that targeting civilians is a crime that the international law set punishment for and is a breach for the principles and values that were established and agreed by the civilized societies. The continuing of targeting and killing children, women and civilians by the Saudi-led coalition and its allies is a crime of many that still committing before the international society who is still dam and deaf to these crimes. This will stand as

a stone in front of the collaboration of the international society and its aims of preserving and protecting the rights and freedoms that will be an international precedent of aggression against the states and societies.

Center Recommendations:

- ▶ Legal Center for Rights and Development calls on all civil society organizations and international organizations, especially United Nations organizations, to shoulder their moral and humanitarian responsibilities towards the crimes committed by the Saudi regime and its coalition against humanity and humanity.
- ► calls on United Nations and Security Council to preserve its remaining reputation and to stop the war and the bloodshed of Yemenis and reduce the crimes commission against Yemen I children and women.
- ▶ And calls for dispatching international commissions of inquiry as soon as possible to investigate on this crime and the other ones and to bring perpetrators in these crimes to international justice.
