Incident Details:

In the early hours of Saturday, 2 December 2017, the Saudi warplanes targeted a civilian vehicle on the main road in Wadi Habab area. Nabil Hussein Al-Zaidi, a residents **Sarwah** District, was in his way to the capital Sana'a while the targeting. He was killed immediately and his car (taxi, Camry model 2003) was completely destroyed.

victims and witnesses' Testimonies:

Witness / Zainallah Hussein Al-Zaidi, 38 years old, and the victim's brother, the owner of the targeted car, told us the details of the incident, saying:

"At two o'clock at night of Friday, 2 December 2017, the Saudi Arabian warplanes targeted my brother Nabil by an air raid while he was on his car on the public road in Wadi Habab area heading to the capital Sana'a where he and his family live. The attack resulted in the immediate killing of Nabile Hussein and the complete destruction of his car and Janbyah which is so expensive about hundred thousand Yemeni riyals.

Witness / / Mubarak Hussein Hamoud Al-Zaidi, 30 years old, and the victim's brother told us:

"While my brother Nabil was on his way to the capital Sana'a from our village of Dtwar in Serawah district on his car, the Saudi warplanes targeted him on the main road in Wadi Habab air, killing My brother Nabil immediately. His car was destroyed completely".

"he added."

He was targeted for no fault except that he was traveling on the main road to see his family. "

Witness / Muhammad Saleh Shuwail Al-Zaidi, 52 years old, and one of area residents told us:

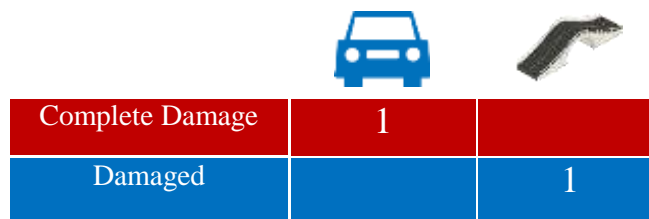
"On Saturday, December 2, the Saudi warplanes targeted, Nabil Hussein Al-Zaidi, while he was traveling on his taxi in the area of Wadi Habab with an air strike that killed him and destroyed his car completely".

Description of the violation according to the international humanitarian law:

legal center has revised the incident and made a full field scan on the targeted area specially the road and the vehicle that was targeted. The area does not represent a military target. It is known that targeting civilians is a crime that the international law set punishment for and is a breach for the

principles and values that were established and agreed by the civilized societies. The continuing of targeting and killing children, women and civilians by the Saudi-led coalition and its allies is a crime of many that still committing before the international society who is still dam and deaf to these crimes. This will stand as a stone in front of the collaboration of the international society and its aims of preserving and protecting the rights and freedoms that will be an international precedent of aggression against the states and societies.

Center Recommendations:

- ▶ **?** Legal Center for Rights and Development calls on all civil society organizations and international organizations, especially United Nations organizations, to shoulder their moral and humanitarian responsibilities towards the crimes committed by the Saudi regime and its coalition against humanity and humanity.
- ▶ **?** calls on United Nations and Security Council to preserve its remaining reputation and to stop the war and the bloodshed of Yemenis and reduce the crimes commission against Yemen I children and women.
- ▶ **?**And calls for dispatching international commissions of inquiry as soon as possible to investigate on this crime and the other ones and to bring perpetrators in these crimes to international justice.
