## Abstract:

Since 26th of March 2015, the Saudi coalition warplanes have been continuing committing its crimes and genocides against Yemeni civilians. One of these continuing crimes is what happened to the house of Mohammed Abduladeem Al-Lablub in Dahyan city, Majz district od Sa,ada governorate when the Saudi warplanes launched an airstrike on his house. The airstrike resulted in the killing of all members of the family except the father who was working outside his house. The attack also damaged three neighboring houses.

## Incident Details

At 8:00 pm on Wednesday, May 9, 2018, a military aircraft of the Saudi Aggression Coalition launched an airstrike by a deadly bomb on the house of Mohammed Abduladeem Al-Lablub in Dahyan city, Majz district od Sa,ada governorate. The brutal raid destroyed his house on the heads of his wife and children, the victims were his wife Fatima Ali Alama, and his four children Ali, Ihsan, Ayat and Zainab Mohammed, who was only two weeks old. Their innocence and dreams of life were assonated, they have been killed for no reason. The horrific crime caused by the brutal raid on this family and the innocent childhood is an evident for the black and dark side of the Saudi coalition.

## **victims and witnesses' Testimonies:**

**Mohammed Abduladeem Al-Lablub, 30 years old, is the father of the afflicted family, his all family members were killed by the airstrike. We met him and asked him about the incident details and he replied saying:**

"A few days ago, I left my home looking for work through which I can feed my wife and my four children. The Saudi aggression broke and burned everything from the sources of income and sources of life and life. At 9:00 on Wednesday, 9 May 2018, I have received a calling from my father telling me that I have to get back home quickly, he did not tell me about what had happened. When I arrived my home, they told me about what had happened to my family members and that they have been killed all. The Saudi aggression coalition brutally assassinated our rights and the rights of my children and wife to live and have the right to housing and shelter."

**Hassan Hassan al-Hadi, 38 years old, is an eyewitness from the town of Dahyan who took part in pulling the bodies of the killed victims out of the rubbles, we met him and he told us the details of the incident saying:**

" When I was on my way back to my house after I had prayed at the mosque, suddenly I heard the sound of an air raid on the city of Dahyan. I and others rushed to the targeted location and before we reached the target house, the warplanes returned flying in the area sky which caused fear among the people who came for helping the victims. After the warplanes left the sky, we saw a horrible crime, the blood of the victims covered the targeted place and the neighboring houses got damaged. There are no camps or weapons stores in this place, the crime is terrible."

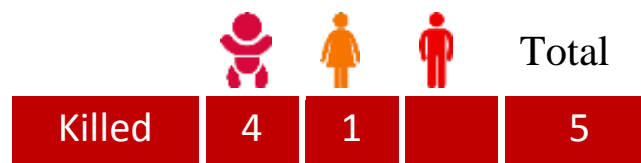
**Abduladeem Mohammed Abdel-Karim Al-Lablub, is nearly 60 years old, he is the grandfather of the afflicted family. He participated in the efforts of recovering the bodies of his children, the victims who**

**were killed by the brutal raid on their home. We met him and the tears, sorrow and pain is clear on his face. He said to us:**

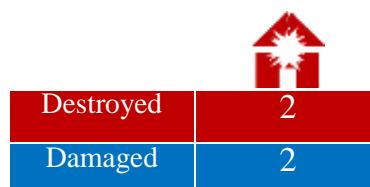
"At eight o'clock on Wednesday night, while I was in my house, about five hundred meters from the home of my son Mohammed, I felt only the air raid that was close our houses. I heard some of our neighbors talking among themselves that the raid targeted a civilian house. A quarter of an hour after the raid, I heard some people were asking for a help and saying that the attack targeted the house of my son Mohammed, the brutal raid targeted my son' s house. My family was terrified and I went to see what had happened, despite my family 's advice not to go there since the warplanes still flying in area sky and would return targeting the paramedics as soon as they reach to the targeted house. When I arrived, I was surprised to see the house became ruins of rubble and the children of my son and his wife were killed. The scene was so terrible; the blood is everywhere around the targeted home."

## **Description of the violation according to the international humanitarian law:**

Legal Center made field visit to the targeted position and found it a civil place has no military presence. It is known that targeting civilians is a crime that the international law set punishment for and is a breach for the principles and values that were established and agreed by the civilized societies. The continuing of targeting and killing children, women and civilians by the Saudi-led coalition and its allies is a crime of many that still committing before the international society who is still dam and deaf to these crimes. This will stand as a stone in front of the collaboration of the international society and its aims of preserving and protecting the rights and freedoms that will be an international precedent of aggression against the states and societies.

## **Center Recommendations:**

- Legal Center for Rights and Development calls on all civil society organizations and international organizations, especially United Nations organizations, to shoulder their moral and humanitarian responsibilities towards the crimes committed by the Saudi regime and its coalition against humanity and humanity.
- Calls on United Nations and Security Council to preserve its remaining reputation and to stop the war and the bloodshed of Yemenis and reduce the crimes commission against Yemen I children and women.
- And calls for dispatching international commissions of inquiry as soon as possible to investigate on this crime and the other ones and to bring perpetrators in these crimes to international justice.
