Incident Details

At 12 noon on Saturday, May 5, 2018, the Saudi Warplane launched three air strikes on Ma'aali / Al-Zabyah area, the first attack targeted the house of Hassan Salman Jaber which resulted in the killing of 6 civilians of Hassan's family members including him and destroyed their home completely. The killed victims were Hassan Salman Jaber, his wife Fatema Eydah Farhan and his four children: Mustafa, Thurya, Ghalya and the infant Mujahed. The warplanes after the first attack carried out two barbaric raids targeted the second house of Hassan and his Tractor which was the only source of livelihood for the affected family.

victims and witnesses' Testimonies:

Salim Eydah Farhan, 23 years old, is a relative of the afflicted family, we met him and he spoke to us about the most important details of the incident saying:




"As usual, families gather for lunch during the afternoon and this is what happened with my relative Hassan Salman Jaber, who was with his entire family of seven civilians, his wife Fatima (my sister) and their five children. They were having lunch, but the Saudi Arabian warplanes launched an air raid on their home, bringing their bodies to shredded pieces that difficultly collected by the area's residents to be buried. The raid resulted in the killing of the head of the family, his wife and four of his children, only Maryam Hassan, eight years old, was survived from the family. Then two airstrikes were carried out on the second house of Hassan that was inhabited by 14 civilians and destroyed it completely as well as destroyed his Tractor."

Salem Hussein Farhan, 37, an eyewitness and a resident of the area, met and told us:

"When I returned home after the noon prayer, I saw the Saudi warplanes launching raid on the house of Hassan Salman Jaber and completely destroyed it over the head of Hassan and all family's members. A number of civilians and I rushed to rescue the injured victims and pull victims out the rubbles but the warplanes returned targeting the by two airstrikes, one of which targeted the another house owned by Hassan and inhabited by a poor civilian family of 14, most of them women and children, who miraculously escaped after the first attack and the second attack destroyed the tractor of Hassan."

Description of the violation according to the international humanitarian law:

Legal Center made field visit to the targeted position and found it a civil place has no military presence. It is known that targeting civilians is

a crime that the international law set punishment for and is a breach for the principles and values that were established and agreed by the civilized societies. The continuing of targeting and killing children, women and civilians by the Saudi-led coalition and its allies is a crime of many that still committing before the international society who is still dam and deaf to these crimes. This will stand as a stone in front of the collaboration of the international society and its aims of preserving and protecting the rights and freedoms that will be an international precedent of aggression against the states and societies.

Center Recommendations:

- Legal Center for Rights and Development calls on all civil society organizations and international organizations, especially United Nations organizations, to shoulder their moral and humanitarian responsibilities towards the crimes committed by the Saudi regime and its coalition against humanity and humanity.
- Calls on United Nations and Security Council to preserve its remaining reputation and to stop the war and the bloodshed of Yemenis and reduce the crimes commission against Yemen I children and women.
- And calls for dispatching international commissions of inquiry as soon as possible to investigate on this crime and the other ones and to bring perpetrators in these crimes to international justice.
