## **Incident Details**

At 3 Am, on Thursday, May 10, 2018, the Saudi warplanes launched two airstrikes on the farm of Saed Yahya Qura'ah that is located in Eyal Mohammed area Nehm district, Sana'a governorate while the presence of his family members in this farm. The attacks resulted in the killing of two women who were working in the farm and the injuring of 6 other from the family and the relatives of Saed Yahya Qura'ah including his wife Nafa'ah Mohsen Ghalib.

## **victims and witnesses' Testimonies:**

**Maysari Saed Qura'ah, the brother of the killed victims (Jamaila Saed Qura'ah and Sabah Saed Qura'ah), talked to us about the incident saying:**

" While my sisters, mother and some of my relatives were working in the farm, the Saudi warplanes launched two airstrikes respectively on the farm killing two of my sisters (Jamaila and Sabah) and injuring 6 other among them my mother. Me and some of the residents aided the victims and took them to the hospital. The targeted area is purely a civil place which has no presence of conflict. Attacking civilians and children is a prohibited action and the world shall stop these actions against Yemeni civilians. The attacks also caused in the damage of the farm."




**Naji Ahmed Qayed is one the area's Sheikhs whom we met with. Naji told us the incident details saying:**

" Since three years of this war on Yemen, the Saudi warplanes have killed and still killing tens of civilians and destroying their properties, homes and farms. Many attacks have targeted civilians while they are in markets, jobs and even in the mosques and places of displacing. The attacks also during three years have destroyed everything related with the civilians' needs.

The last of these attacks and crimes is the targeting of the family members of Saed Yahya Qura'ah mostly women and children while they were working at their farm. The attacks killed two women, injured 6 civilians mostly children and damaged the farm."

## Description of the violation according to the international humanitarian law:

Legal Center made field visit to the targeted position and found it a civil place has no military presence. It is known that targeting civilians is a crime that the international law set punishment for and is a breach for

the principles and values that were established and agreed by the civilized societies. The continuing of targeting and killing children, women and civilians by the Saudi-led coalition and its allies is a crime of many that still committing before the international society who is still dam and deaf to these crimes. This will stand as a stone in front of the collaboration of the international society and its aims of preserving and protecting the rights and freedoms that will be an international precedent of aggression against the states and societies.

### **Center Recommendations:**

- Legal Center for Rights and Development calls on all civil society organizations and international organizations, especially United Nations organizations, to shoulder their moral and humanitarian responsibilities towards the crimes committed by the Saudi regime and its coalition against humanity and humanity.
- Calls on United Nations and Security Council to preserve its remaining reputation and to stop the war and the bloodshed of Yemenis and reduce the crimes commission against Yemen I children and women.
- And calls for dispatching international commissions of inquiry as soon as possible to investigate on this crime and the other ones and to bring perpetrators in these crimes to international justice.
