

Incident Details

Al-Jerba area is one of the agricultural areas in Al-Jarahi Directorate which is famous of planting Mango, this area has many farms of fruits in which many of civilians are working. However, the Saudi Arabian warplanes, as usual in targeting farmers and destroying their farms, attacked a farm at 10:30 am on Saturday, killing two workers, damaging Mango trees and the injuring a citizen who was passing along the line next to the farm. Targeting farms is not something new and it not the first and will not be the last.

victims and witnesses' Testimonies:

Ghamddan Muhammad Ali Ajash, told us the details saying:


"The workers were working on the farm during the bombing which resulted in the killing of two of them without any guilt, the farm belongs to Sheikh Hamoud al-Basha and it was rented to Adel Al-Hubaishi from Ibb governorate. There is no justification for bombing and targeting the farmers, we are civilians and workers have no guilt so why they deliberately targeting us?

Sheikh Ibrahim Hamoud Al-Aidarous, reported us the incident details saying:

"The Saudi warplanes targeted a farm of two citizens at two o'clock on Saturday, killing two workers and injuring a driver of a truck with shrapnel when he was passing in the public road. This crime is not the only one committed by the Saudi alliance warplanes but it has been preceded by a series of crimes, including the crime of targeting the farms of the area

residents such as the bombing of Nouman Mutia's farm last days and how much his farm was destroyed. All the people of the area are civilians who have no guilt and there is no justification for bombing the farms and killing the workers there."

Incident Results:



Description of the violation according to the international humanitarian law:

Legal Center made field visit to the targeted position and found it a civil place has no military presence. It is known that targeting civilians is a crime that the international law set punishment for and is a breach for the principles and values that were established and agreed by the civilized societies. The continuing of targeting and killing children, women and civilians by the Saudi-led coalition and its allies is a crime of many that still committing before the international society who is still dam and deaf to these crimes. This will stand as a stone in front of the collaboration of the international society and its aims of preserving and

protecting the rights and freedoms that will be an international precedent of aggression against the states and societies.

Center Recommendations:

- Legal Center for Rights and Development calls on all civil society organizations and international organizations, especially United Nations organizations, to shoulder their moral and humanitarian responsibilities towards the crimes committed by the Saudi regime and its coalition against humanity and humanity.
- Calls on United Nations and Security Council to preserve its remaining reputation and to stop the war and the bloodshed of Yemenis and reduce the crimes commission against Yemen I children and women.
- And calls for dispatching international commissions of inquiry as soon as possible to investigate on this crime and the other ones and to bring perpetrators in these crimes to international justice.
