Incident Details

The farm of Fadel Abbas Jaber is located in the area of Jaber of Al-Jarahi Directorate while the farm of Sheikh Serdah Osama Ali is located in the area of Shia'abat Dali, Al-Jarahi Directorate – Hodeida governorate. As in any farm, a lot of simple workers are working in these two farms. On Saturday at 10 am, the Saudi warplanes launched two raids targeted Fadel Abbas's Farm which resulted in the killing of four civilians and the injury of others. The next day, the aircraft targeted the two farms of Sheikh Sardah and caused in the injury of four workers and the damage of more than forty mango trees.

victims and witnesses' Testimonies:

Mahmoud Awad Ahmed Kmal, 30 years, is a relative of one of the victims, he reported us saying:

" It was 10 am on Saturday, May 12, 2018 when the Saudi warplanes targeted my relatives while they were working in harvesting the mango fruits. The targeting resulted in the killing of four civilians among them Fadel Abbas, the injury of my relatives/ Ahmed and Mohammed Awad and the destruction of mango trees.

After a day of this crime, the Saudi warplanes launched two airstrikes on the farm of Sheikh Serdah wounding four workers, destroying the mango trees and spreading the fear among civilians without any justification."

Majd Muhammad Awad Mahthali, said:

" On Saturday morning, the Saudi warplanes launched two raids targeting the Al-Jabali farm resulted in the killing of four civilians and wounded

others. After four days of this crime in May 13, 2018, the Saudi warplanes launched two raids on the farm of Sheikh Serdah Mustafa who was injured then.”

The injured victim/ Mustafa Abdo Ghalib Kmal, 15 years old, said:




"I was working at the Sheikh Serdah farm and at 4:00 pm on Sunday, 13 May 2018, an air raid targeted us directly, I and three other workers were injured. The raid destroyed more than 40 trees and caused terror among us.”

Sheikh/Serdah Osama Ali Mahthali, 51 years, is the owner of one of the targeted farms, told us:

"The air force of Saudi coalition launched an airstrike on my farm resulted in the injury of four workers who were harvesting the fruits of mango and the destruction of 40 trees Mango. This crime was not the first crime in this area, the region was targeted on last Saturday by two raids that killed four civilians. There is no justification for these brutal crimes committed against us every day, "he said.

Description of the violation according to the international humanitarian law:

Legal Center made field visit to the targeted position and found it a civil place has no military presence. It is known that targeting civilians is a crime that the international law set punishment for and is a breach for the principles and values that were established and agreed by the civilized societies. The continuing of targeting and killing children, women and civilians by the Saudi-led coalition and its allies is a crime of many that still committing before the international society who is still dam and deaf to these crimes. This will stand as a stone in front of the collaboration of the international society and its aims of preserving and protecting the rights and freedoms that will be an international precedent of aggression against the states and societies.

Center Recommendations:

- Legal Center for Rights and Development calls on all civil society organizations and international organizations, especially United Nations organizations, to shoulder their moral and humanitarian responsibilities towards the crimes committed by the Saudi regime and its coalition against humanity and humanity.
- Calls on United Nations and Security Council to preserve its remaining reputation and to stop the war and the bloodshed of Yemenis and reduce the crimes commission against Yemen I children and women.
- And calls for dispatching international commissions of inquiry as soon as possible to investigate on this crime and the other ones and to bring perpetrators in these crimes to international justice.
