Incident Details

At 11:00 am on Thursday, May 3, 2018, the Saudi Arabian Coalition Forces launched random bombardment of rockets and artillery shells at the Thweib Alsufra area – Haidan Directorate - Saada Governorate. The shelling targeted the home of Qassim Mufreh, the house was full of eight civilians - Most of them were women and children. The missile destroyed the house on the heads of its residents. The shelling resulted in the injury of eight civilians among them 5 children, two women and a man. Some of the injured civilian were seriously injured. The whole family now is without home and they do not know how to live and where they can live.

victims and witnesses' Testimonies:

Abdullah Saleh Wahan, 36 years old, is an eyewitness and a neighbor of Qassim Mufreh, he told us the incident details saying:

" At 11 pm on Thursday, May 3, 2018, the forces of the Saudi Aggression Coalition launched a rocket attack on the area of Thweib Alsufra in which it bombed the home of my neighbor Qassim Mufreh. The attack injured all family's members and destroyed their home. The residents of the area rushed to the targeted home and saved those who were injured. The targeted family consists of eight civilians mostly children. After committing the crime, the Saudi warplanes intensively flew in the sky of the targeted area preventing the people from aiding the victims of its targeting."

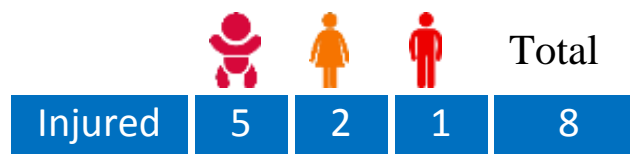
Hussein Mufreh Saleh Mufreh, 40 years old, is the brother Qassim Mufreh whose home was targeted by the Saudi warplanes. Hussein reported us the details of the incident saying:

" We were sleeping in our house and suddenly woke up to the sound of the rocket and artillery bombardment by the coalition of the Saudi

aggression on our residential area. One of these rockets bombed the home of my brother Qassim causing the injury of his all family's members including him. After bombing, I and some of residents rushed to my brother's home to save them and when we arrived we took the injured persons to the hospital. The warplanes did not leave the sky of the targeted area, it continued flying in a way made us feel that we are in danger. The neighbors got psychological problems due to the targeting on their civil area.” f

Description of the violation according to the international humanitarian law:

Legal Center made field visit to the targeted position and found it a civil place has no military presence. It is known that targeting civilians is a crime that the international law set punishment for and is a breach for the principles and values that were established and agreed by the civilized societies. The continuing of targeting and killing children, women and civilians by the Saudi-led coalition and its allies is a crime of many

that still committing before the international society who is still dam and deaf to these crimes. This will stand as a stone in front of the collaboration of the international society and its aims of preserving and protecting the rights and freedoms that will be an international precedent of aggression against the states and societies.

Center Recommendations:

- Legal Center for Rights and Development calls on all civil society organizations and international organizations, especially United Nations organizations, to shoulder their moral and humanitarian responsibilities towards the crimes committed by the Saudi regime and its coalition against humanity and humanity.
- Calls on United Nations and Security Council to preserve its remaining reputation and to stop the war and the bloodshed of Yemenis and reduce the crimes commission against Yemen I children and women.
- And calls for dispatching international commissions of inquiry as soon as possible to investigate on this crime and the other ones and to bring perpetrators in these crimes to international justice.
